COVID-19 Update September 01, 2022

As of **August 31, 2022**, the total of laboratory-confirmed and probable COVID-19 cases reported among Connecticut residents is **875,574**; **2,828** have been reported in the past 7 days. **Three hundred fifty-three** patients are currently hospitalized with laboratory-confirmed COVID-19; of these, **149** (42.21%) are not fully vaccinated.

Test positivity is calculated as a rolling 7-day test positivity by specimen collection date; all positive molecular (PCR/NAAT) test results are divided by all molecular (PCR/NAAT) test results (positive and negative) for the last 7 days and multiplied by 100 to reach a percentage. Hospitalizations over the past 7 days indicates the change in the number of patients hospitalized with COVID-19 over that period. Deaths over the past 7 days indicates the number of new COVID-19 associated deaths reported; deaths are reported once weekly.



The chart below shows the number of new COVID-19 cases reported to CT DPH by week of specimen collection or onset of illness. Case data includes probable cases based on positive antigen test results. During the previous 7 days (August 25-31), there were 2,828 new COVID-19 cases, including cases among people residing in the community and congregate settings, such as nursing homes, managed residential communities, and correctional facilities.







Community Transmission of COVID-19

There were 2,828 new COVID-19 cases with specimen collection date during August 25-31, as shown in the map below. During this seven-day period, the statewide case rate was 78.426 per 100,000 CT population; there were more than 100 new COVID-19 cases in 2 towns.

Epidemiology of COVID-19 by Vaccine Status

Methodology

To determine cases of COVID-19 among fully vaccinated persons or among those who have received an additional dose of COVID-19 vaccine, DPH matches COVID-19 case data with the vaccine registry to determine which cases meet the definition of being fully vaccinated or having received an additional dose and which are also vaccine breakthrough cases.

- A case of COVID-19 in a fully vaccinated person (e.g., vaccine breakthrough case) is defined as a person who has a positive PCR/NAAT or antigen test in a respiratory specimen collected ≥14 days after completing the final dose of an FDA-authorized or approved COVID-19 vaccine series and who did not have a previously positive COVID-19 test <90 days prior to the positive test currently under investigation.
- A case of COVID-19 in a fully vaccinated person who has received an additional dose is defined
 as a person who has a positive PCR/NAAT or antigen test in a respiratory specimen collected ≥14
 days after receiving an additional dose of any COVID-19 vaccine and who did not have a
 previously positive COVID-19 test <90 days prior to the positive test currently under
 investigation.

All data presented below are preliminary and subject to change.

Data

The table below shows new COVID-19 cases for the previous 7 days August 25, 2022 - August 31, 2022 by vaccination status. The percentage of cases among fully vaccinated individuals is influenced by the high proportion of the population that is eligible for and has completed a vaccine series, and should be considered in light of the overall proportion of vaccinated individuals who have contracted the virus.

As of **August 31, 2022**, 272,137 cases of COVID-19 among fully vaccinated persons in Connecticut have been identified. Those 272,137 cases account for 9.89 percent of the 2,751,910 persons who are fully vaccinated.

Since the beginning of the pandemic, 603,437 cases have been identified among individuals who are not fully vaccinated.

One thousand one hundred seven COVID-19 related deaths have occurred among the 272,137 fully vaccinated persons confirmed with COVID-19.

The table below shows cases and deaths among fully vaccinated persons, and among persons who have received an additional dose, by age group. As shown below, persons who have received an additional dose are a subset of those cases that are fully vaccinated.

SARS-CoV-2 Variant Surveillance

The Centers for Disease Control and Prevention (CDC) have identified three types of SARS-CoV-2 variants: variants of concern, variants being monitored, and variants of high consequence. The definitions for the three different variant categories and substitutions of therapeutic concern can be found here: SARS-CoV-2 Variants of Concern | CDC.

Different terminology has been developed by international scientists for naming SARS-CoV-2 variants. Recently, the World Health Organization (WHO) developed new labels for describing these variants to the public. Below, the WHO label are listed for each variant described.

Below are data on variants of concern and variants being monitored identified among Connecticut residents. No variants of high consequence have been defined by CDC to date.

Data presented are based on variant data reported directly to DPH and include data since January 2021-present.

Data below represent sequences that have been reported to DPH as of 08/31/2022 with specimen collection dates between 01/12/2021 and 08/21/2022. **The total number of SARS-CoV-2 sequences reported to DPH with a valid specimen collection date is 42302.** Data are preliminary and updated as new data are received.



As of July 21, 2022, the plot below has been updated to reflect the following changes:




Number of Molecular and Antigen Tests for COVID-19 with Specimen Collection Date During August 25-31

Number of New COVID-19 Cases by Age Group




Weekly Incidence by Age Group




Rate of COVID-19 cases by County




Cumulative Number of COVID-19 Cases and COVID-19-Associated Deaths by Date

Number of COVID-19-Associated Deaths by Date of Death




Hospitalization Surveillance

Patients Currently Hospitalized by Connecticut County





Molecular Tests

To date, DPH has received reports on a total of 15,276,085 molecular COVID-19 laboratory tests; of these 15,136,286 test results were received via electronic laboratory reporting (ELR) methods from commercial laboratories, hospital laboratories, and the Dr. Katherine A. Kelley State Public Health Laboratory. The chart below shows the number of tests reported via ELR by date of specimen collection and test result.

Test results may be reported several days after specimen collection. Data are incomplete for most recent dates shaded in grey. Data for previous dates are routinely updated.

As of August 31, 2022







Number of COVID-19 Cases by Age Group




Number of COVID-19-Associated Deaths by Age Group


Number of COVID-19 Cases by gender


Number of COVID-19-Associated Deaths by gender




Cumulative Number of COVID-19 Cases by Town




Rate of COVID-19 Cases Statewide and by County




Rate of COVID-19-Associated Deaths Statewide and by County




Rate of COVID-19 Cases by Age Group




Rate of COVID-19-Associated Deaths by Age Group



Rate of COVID-19 Cases by Gender




Rate of COVID-19-Associated Deaths by Gender



Number of COVID-19 Cases by Race\Ethnicity





Number of COVID-19-Associated Deaths by Race\Ethnicity



The following graphs show the number of COVID-19 cases and COVID-19-associated deaths per 100,000 population by race and ethnicity. Crude rates represent the total cases or deaths per 100,000 people. Age-adjusted rates consider the age of the person at diagnosis or death when estimating the rate and use a standardized population to provide a fair comparison between population groups with different age distributions. Age-adjustment is important in Connecticut as the median age of among the non-Hispanic white population is 47 years, whereas it is 34 years among non-Hispanic blacks, and 29 years among Hispanics. Because most non-Hispanic white residents who died were over 75 years of age, the age-adjusted rates are lower than the unadjusted rates. In contrast, Hispanic residents who died tend to be younger than 75 years of age which results in higher age-adjusted rates.

The 2020 Connecticut and 2000 US Standard Million populations were used for age adjustment; population estimates from: <u>DPH Population Statistics</u>. Categories are mutually exclusive. Cases missing data on race/ethnicity are excluded from calculation of rates. NH=Non-Hispanic
